2019 Mooring Rental Agreement

ONEC and the Sailboat Owner hereafter agree that the sailboat, as described below, may anchor at an assigned mooring for the specified period subject to the following conditions:

1. Use of the anchorage and its moorings is accepted at the sole risk of the Owner, and the owner hereby releases ONEC from any and all claims for loss or damage, however caused.

Warning: The anchorage where the ONEC moorings are located is an open area and may not be suitable in all weather conditions. Sailboats using the ONEC moorings are to be relocated to safer areas by their Owners when conditions are expected to deteriorate and the anchorage becomes unsafe.

2. The mooring, provided by ONEC, includes a mooring ball, a chain and an anchor. The Owner is responsible for providing any additional equipment that may be required to properly secure the sailboat.

3. The mooring will be provided as-is. The Owner fully understands that ONEC does not in any way guarantee, nor can it be held liable for, the condition or reliability of the moorings.

4. ONEC assumes no liability for fire, theft, collision, vandalism, deterioration of equipment or acts of God while a sailboat is moored at an ONEC mooring.

5. ONEC assumes no liability for personal injury or loss of life of the owner, his/her guests, servants, agents or employees during the use of ONEC moorings.

6. Moorings are rented for a specific sailboat and owner and may not be sublet, loaned or used for another sailboat, nor can more than one sailboat use a single mooring without the express written permission of ONEC. Two club tenders are available to owners of moored sailboats. Privately owned tenders may be kept at ONEC for a per tender storage fee (subject to space availability).

7. Owners of moored sailboats will carry Third Party Liability Insurance necessary to cover any losses but not less than \$1,000,000.00. Valid policy documentation must be submitted with mooring agreement for review/approval.

8. The Owner is responsible for following all Federal, Provincial and Municipal Acts, Regulations and Policies that apply when the sailboat is located on an ONEC mooring. Such Acts, Regulations and Policies include but are not limited to:

- Canada Shipping Act;
- Competency of Operators of Pleasure Craft Regulations;
- Small Vessel Regulations;
- Collision Regulations;
- Vessel Operation Restriction Regulations;
- Vessel Pollution and Dangerous Chemicals Regulations; and
- Province of Ontario Environmental policies.

9. The Owner agrees to abide by all aspects of the ONEC private boat mooring and membership policies, copies of which are available upon request.
